Dear Applicant,

You have recently requested an application for membership into the Chaubunagungamaug Nipmuck Band. Enclosed you will find ancestry charts, which you will need to fill out for every member of your family, tracing back to an identifiable ancestor on our base list, located on the last 2 pages of your application packet. This list is the 1861 Earle Report, and the 9/1/1891 Trust Disbursement for the Webster/Dudley Indians.

Please include with your application: Birth, Marriage, and Death certificates along with any other supporting information which shows your connection to an identifiable ancestor on one of these lists. Please remember that a photocopy will not be accepted. We must have certified copies of all birth, marriage, and death certificates. These certified copies may be obtained at the proper town hall. When your charts and forms are completed and signed, you may mail them, or you may submit them at the monthly Council meetings in person. If you are submitting applications for your children, or a member of your family is already a duly enrolled member, you will only need their Application and Affirmation letter, along with their birth certificate. You do not need to submit multiple sets of Ancestry Charts.

A list of required documentation for enrollment is attached. Upon receipt of a completed application, the Enrollment Committee will review the application and recommend to the Tribal Council whether the application should be approved or disapproved for membership in accordance with the requirements of both the Tribal Constitution and the Tribal Enrollment Code.

If you need assistance in filling out any of these forms, please contact you Tribal Council representative. We will be happy to answer any questions you may have or schedule an appointment. Remember the entire Council and Enrollment Committee are here to assist you in any way we can, however it is the applicant's responsibility to obtain the necessary documentation needed to complete your application for membership status into the Band.

- Complete Ancestry Chart. Use more than 1 page if needed to trace back to a Nipmuck Ancestor on the Chaubunagungamaug Ancestor List.
- ☐ Complete Individual History Chart.
- ☐ Certified Birth Certificate of Applicant.
- Certified Marriage Certificate of Applicant if applicable. Please include current and previous marriages.
- Any other name change documents of applicant if needed.
- Nipmuck Parents Certified Birth, Marriage and Death Certificates if
- Nipmuck Ancestors Certified Birth, Marriage and Death Certificates if applicable. Certified documentation must link the applicant to a Nipmuck Ancestor on the Chaubunagungamaug Ancestor List provided. Only one set of certified Certificates is needed for a family applying for membership. (Example: A child applying for membership will not need the parents certified certificates if the parents are also applying for membership and providing certified certificates. Only one set of their Nipmuck Ancestors certificates will need to be provided.)
